**Parent / School Conduct agreement during Covid 19 Global Pandemic V2
September 2020**

Parents and carers must adhere to the following rules put in place to keep all adults and children as safe as possible and limit the potential for spreading Covid 19.

1. Parents understand that the school will make every attempt to social distance children whilst they are in school but they cannot guarantee that children will not be in contact with other children within their bubble or with the adult allocated to their bubble.
2. Following Government and medical advice, your child will be expected to wash their hands frequently, using soap and water to reduce the chances of transmission of the virus. We expect your support and understanding for this and for you to discuss, in an age appropriate way these expectations with your child.
3. Clothing- your child is required to modified wear school uniform, please ensure they wear comfortable **clean clothes daily**, Clothing must be suitable for outdoor play.
4. Please ensure you have ordered your child their lunch (KS1 and EYFS) or that they have with them a healthy packed lunch each day (KS2) , along with a named water bottle, they will not be able to bring any other items with them, they will need to bring a school rucksack.
5. Parents will not allow their child to bring any other items to school other than the items listed above.
6. Parents understand that any child who is unwell will not be admitted to school.
7. Parent will follow the one-way system for dropping off their child at school at their class specified time. They will wait in the allocated areas and arrive at the correct time for pick up and drop off. This will be sent to parents.
8. One adult only will attend drop off and collection. Younger or older siblings who are not attending school will not be brought to drop off or pick up
9. Children will only be admitted / dismissed at their allocated time. Parents must adhere to these timings and stand in the allocated spaces.
10. Parents understand that if any member of the household is displaying symptoms of Covid 19, the child is not permitted onto the site and the school must be kept informed of test results, prior to them being allowed back. Unless a test result is negative, we expect a 14-day isolation period to apply.
11. Parents understand that if their child starts to develop symptoms whilst at school, they must be collected within 30 minutes of notification being received. Children over the age of 5 should then be tested for Covid 19 along with all other members of the household and the school informed of the results as soon as possible.
12. Parents understand that in the instance of a positive result for Covid 19, they will agree to the tracking and tracing of this information to minimise risk to others. Results from the test are to be shared with school, whether positive or negative. Until the results have been shared, the child must isolate at home with all members of their household.
13. Parents are to adhere to the social distancing rules laid down by the Government at all times- keep a distance of 2 metres from others not in your household. Those failing to do so, will be asked to not bring their children and will be reported if deemed necessary.
14. Parents will not stay longer than absolutely necessary; gathering and chatting in groups, will not be tolerated and may result in withdrawal of provision.
15. Please remember to treat all members of staff and other parents and children respectfully and leave as soon as you have dropped off or collected your child.

16. On arrival back at home, wash hands with soap and water and wash the clothes the child has been wearing all day.
17. Parents understand that provision is based on the school having the required staff ratios and that it may be necessary for the provision to cease either temporarily or permanently depending on staff availability.
18. Parents understand that in the event of a positive test from a member of a bubble (either staff or pupil) that the pupils and staff in the bubble will be required to self-isolate for 14 days.
19. Parents understand that the schools safeguarding and behaviour policies still apply during this time.
20. Parents will not be permitted inside the school building, any messages for the office must be made via email/ telephone or class Dojo.
21. Parents guarantee that they will follow the government latest guidance on social distancing and social gatherings.
22. Failure to sign this agreement will result in your child not being admitted to school.
23. Parents understand that attendance is mandatory.

It is vital that all adults and children follow the very strict rules and instructions that are in place. We cannot guarantee that children will be safe from the virus. We can promise that we are trying our very best and following the guidance as set out by the DfE and Public Health England. There will be no penalties for choosing to keep your child at home. We have shared as much information with you as possible so that you can make the right choice for your family.
